ARTICLES OF DISSOLUTION
OF

Pursuant to the provisions of Section 607.1403 of the Florida Business Corporation Act, the undersigned corporation adopts the following Articles of Dissolution for the purpose of dissolving 533 S.W. 179th Avenue, Inc., a corporation organized under the laws of the State of Florida ("Corporation"):

1. The name of the Corporation is **533 S.W. 179th Avenue, Inc.**
2. The Articles of Incorporation of the Corporation were filed on December 8, 1993, under document number ~~P93000083730~~.
