ARTICLES OF DISSOLUTION

Article I

The name of the corporation as currently filed with the Florida Department of State is FirstGroup America, Inc.

Article II

Dissolution of FirstGroup America, Inc. was authorized by the board of directors on March 27, 2008.

Article IV
