**AMENDED AND RESTATED
ARTICLES OF INCORPORATION
OF
LENNAR SECURITIES HOLDINGS, INC.**

The undersigned, Zena M. Dickstein, being a duly elected Vice President of LENNAR SECURITIES HOLDINGS, INC., a Florida corporation (the "Corporation"), hereby states as follows on behalf of the Corporation:

1. The Articles of Incorporation of the Corporation (as amended, the "Articles") were filed with the Secretary of State of the State of Florida on December 9, 1993, under Document Number P93000084172.

2. Pursuant to the requirements of Sections 607.1006 and 607.1007 of the Florida Business Corporation Act, the undersigned hereby certifies, attests and serves notice that the Articles of the Corporation are hereby amended and restated in their entirety to read as follows, which Amended and Restated Articles of Incorporation incorporate amendments to all articles of the Articles of the Corporation:

ARTICLE I -- NAME

The name of this corporation is LNR SECURITIES HOLDINGS, INC. (the "Corporation")

ARTICLE II -- PRINCIPAL OFFICE AND MAILING ADDRESS
