# ARTICLES OF AMENDMENT AND RESTATEMENT OF THE ARTICLES OF INCORPORATION OF AWARE COMMUNICATIONS, INC.

- State State of State The name of the corporation is Aware Communications, Inc. (the "Corporation"). A.
- The Articles of Incorporation were filed with the Florida Sccretary of State on В. December 13, 1993.
- Amendments to the Articles of Incorporation were adopted on March 24, 2009, by the sole shareholder and sole member of the Board of Directors of the Corporation in order to (i) increase the number of authorized shares, (ii) update and simplify the provisions of the Articles of Incorporation, and (iii) amend and restate the Articles of Incorporation in their entirety to read as follows:

#### ARTICLE I - NAME

The name of this Corporation is Aware Communications, Inc.

# ARTICLE II - PRINCIPAL OFFICE
