## ARTICLES OF AMENDMENT

OF

### CHEMICAL POLLUTION CONTROL, INC. OF FLORIDA - A 21<sup>ST</sup> CENTURY ENVIRONMENTAL MANAGEMENT COMPANY

As required by 11 U.S.C. § 1123(a)(6) and pursuant to Section 607.197 of the Florida General Corporation Act, Chemical Pollution Control, Inc. of Florida - A 21<sup>st</sup> Century Environmental Management Company hereby adopts these Articles of Amendment.

FIRST: The name of the corporation is Chemical Pollution Control, Inc. of Florida - A 21<sup>st</sup> Century Environmental Management Company.

SECOND: The Article of Incorporation of Chemical Pollution Control, Inc. of Florida - A 21<sup>st</sup> Century Environmental Management Company are amended by changing the Article number Third so that, as amended, said Article shall read as follows:

The number of shares that the corporation is authorized to issue is one thousand, all of which are of a par value of one dollar each and are of the same class and are to be Common shares. All shares shall have full and equal voting rights and the corporation shall have no authority to authorize or issue non-voting stock.

This amendment of the Articles of Incorporation of Chemical Pollution Control, Inc. of Florida was approved and ordered adopted by United States Bankruptcy Court for the District of Delaware on November 30, 1999, having jurisdiction over the reorganization proceeding In re Philip Services (Delaware), Inc., et al., Case No. 99-02385, pursuant to 28 U.S.C. § 1334.
