ORDER ON PETITION TO DISSOLVE CORPORATION
AND TO APPOINT A RECEIVER OR CUSTODIAN

This Cause having come before the undersigned upon the Petition to Dissolve Corporation and to appoint a receiver or custodian at hearing on December 16, 1999, and having reviewed the file and considered arguments of counsel it is hereby

ORDERED THAT the petition to dissolve is granted and PTC Automation, Inc. is hereby judicially dissolved as of December 31, 1999.

IT IS FURTHER ORDERED THAT this Court shall reserve ruling on the petition to appoint a receiver until all known creditors have been provided notice of this request. Petitioner shall send a copy of this order and of the petition to appoint a receiver or custodian to all known creditors by

certified mail. The creditors shall have twenty days in which to file an objection to the petition to appoint a receiver. The creditors shall have four months from the date of this order in which to file with the clerk of circuit court a claim. Filing may be accomplished by mailing the original proof of claim to the Clerk of Circuit Court, Hillsborough County Courthouse, 401 Pierce St., Tampa, FL 33602. The claim shall state the basis for the claim, the amount of the claim and shall be verified by an authorized agent of the claimant by proof under oath. Any creditors or claimants failing to file proofs of claim within four months of the date of this order shall be barred from participating in the distribution of the assets of the corporation.

PETITION TO DISSOLVE CORPORATION
AND TO APPOINT A RECEIVER OR CUSTODIAN

Petitioner PTC Automation, Inc., by and through its undersigned attorney files this petition to dissolve and to appoint a receiver or custodian and in support thereof states:

COUNT I - PETITION TO DISSOLVE A CORPORATION

1. This is a petition to dissolve a corporation brought pursuant to section 607.1430(5), Florida Statutes (1999).
2. Petitioner is a Florida corporation, with its principal place of business in Hillsborough County, which seeks to have its voluntary dissolution continued under court supervision.

4. All of the Respondents may have a claim to some of the corporate assets by virtue of providing services or products.

9. Shelton L. Snead, is the sole shareholder, and is presently in control of the corporate books, records and bank accounts and wishes to be appointed receiver or custodian pursuant to section 607.1432, Florida Statutes.

WHEREFORE Petitioner requests this Court to grant this petition and enter an order appointing Shelton L. Snead custodian of PTC Automation, Inc., enter a judgment dissolving the corporation and grant whatever other relief the Court deems proper and just.
