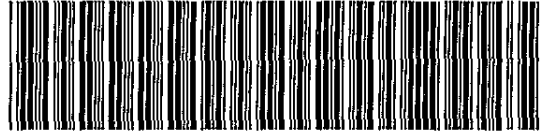

GOLDEN GLOVES MOVING & STORAGE, INC.**


