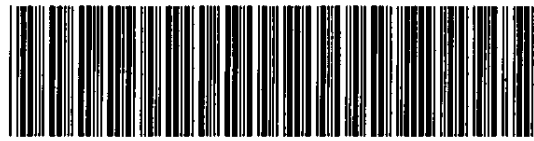

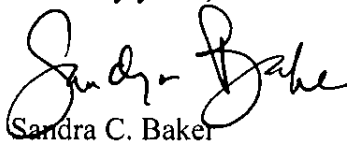

1. Article I of the Articles of Amendment filed on February 12, 1999, is hereby amended to read as follows:

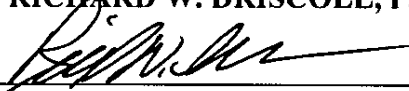
The name of the Corporation is **DRISCOLL & KOTLER, P.A.**
