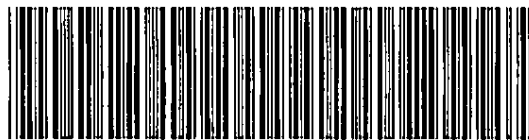

ARTICLE VI CORPORATION

Scope and Purpose

Doherty & Associates, Inc. (D&A), is a technical entity with interests in large movable structures utilized by, or for the public benefit. The sphere of this interest is defined in the corporate By-Laws.

The purpose of this for-profit corporation is to:

- a) publish an industrial directory of the resources involved in the designs, construction and maintenance of these large movable structures, or facilities.
- b) conduct technical seminars covering scientific principles, engineering disciplines, current technologies and state-of-the-art crafts related to these structures and facilities.
- c) provide some professional engineering services to the industry.

Provisions and Corporate Powers are as follows:

Corporate powers are defined and as provided in Chapter 607 of the Florida Statutes, these Articles of Incorporation and Corporation By-Laws. Dissolution is as provided in Florida Statutes, Chapter 607.1401. Shareholder's liability is limited their individual shareholder's equity in the corporation.

These Articles of Incorporation may be modified only by shareholders of record in accordance with the Corporate By-Laws.

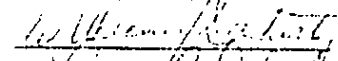
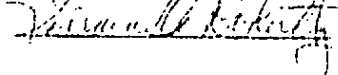
The Corporation is managed by a Board of Directors (maximum of 9 members) and Executive Officers.

The Board sets policy and direction of the corporation. Members of the Board serve at the pleasure of a majority of the shareholders of record in accordance with the By-Laws. Vacancies are appointed by the Chairman with Board approval and in accordance with the By-Laws. Members are invited from the ranks of the shareholders and appointed by the current Board. Directors may be removed by a majority vote of the shareholders voting at a meeting called by the majority of the shareholders of record for that specific purpose.

The Executive Officers (also shareholders) manage the corporation's operation, as defined in the By-Laws and serve at the pleasure of the Board. The President, chief executive officer (CEO) of the corporation, is responsible the conduct and operation of the corporation within the limits set in the Corporation By-Laws.
