**ARTICLE III**

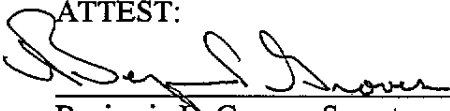
Dissolution of the Corporation was authorized on December 23, 1997.

Dissolution of the Corporation was voted on by the Shareholders of the Corporation and the number of votes cast for dissolution was sufficient for approval.

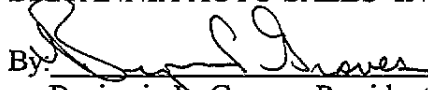
