The effective date and the date of adoption of this amendment is July 31, 2006.

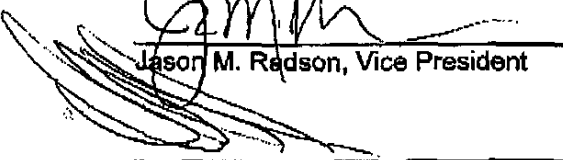

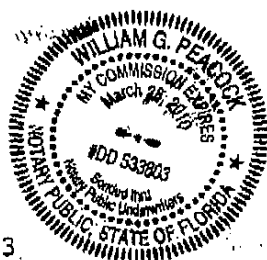

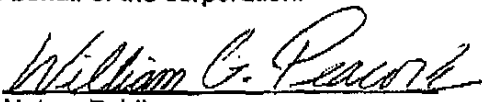
