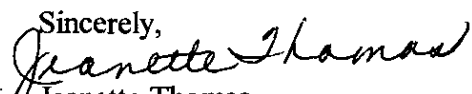
Re: The Country Register of Florida

To Whom It May Concern:

The 1999 Corporation Filing Fee was not paid in 1999, thus dissolving The Country Register of Florida. This was brought to my attention while preparing the corporate income tax in February of 2000. I immediately went back to check my records and it was not paid. I found this to be very peculiar since we have another corporation that was paid for in a timely matter. That corporation is Lewison-Thomas Enterprises, Inc. So I called your office and was informed that our corporation was dissolved due to lack of payment. The person also told me that the filing form for The Country Register of Florida was returned due to an address error. This is where I find something questionable. We did move in 1998, and I changed all addresses for both corporations at the same time. Even if that was missed somehow, we made sure the Post Office kept a forwarding address for 1 year. We never received The Country Register of Florida Corporate Filing Form, but we did receive Lewison-Thomas Enterprises, Inc. Corporate Filing Form in 1999. The person I talked to in your office graciously told me it was my responsibility to pay it regardless of receiving a form, but being human if it is not in front of me it will not get paid. She also told me to write this letter explaining why the fee wasn't paid in a timely fashion. We certainly hope you will waive the reinstate fee in this case. I am enclosing a total of 300.00 dollars which will cover the corporate filing fee for 1999 and 2000 for The Country Register of Florida.
