I represent the above named taxpayer and we recently received the attached letter indicating that the corporation was administratively dissolved for failure to file the 1997 corporate annual report. We are requesting reinstatement and waiver of penalties because we believe there are mitigating circumstances justifying such a request.

It should be apparent from the fact that this taxpayer filed and timely paid the 1998 annual report that we were totally unaware of the oversight in 1997. The taxpayer relocated its offices in the Fall of 1996 and apparently the annual report mailings, including late notices, were not forwarded to the new address. The failure to receive these reports was not noticed by the taxpayer because he assumed that I would file all such required reports. Unfortunately, I assumed that he had done so and as a result the report and fee were not filed.

This company is a small, one-person business and payment of the total requested would result in a serious financial burden. I know that the penalties and fees are established by the Florida legislature, but I am also aware of similar unintentional oversights in which late penalty waivers have been granted.
