TO THE REINSTATEMENT DEPT:

As per my conversation with your reinstatement clerk, yesterday, Thursday, November 29th, 2001, I humbly come to explain my situation and the re-instatement of my corporation. This letter is to request a waiver of the penalty charges that incurred in my corporation. The reason for this request is that not only did I not receive the annual reports for 2000 and 2001 because my address was wrong and the mail system did not forward it, but I sent a letter to your department requesting the change of address and it was not done.

I would never willingly close my corporation because it is a most important and serious matter. In 1995 it closed because I had an accident and I sent in the monies to rectify this situation. I want your department to be aware that I treat this annual report very seriously and would never let it be mishandled, but now I see my corporation closed because it was not my fault. People tell me that I can just re-incorporate and not pay these fees, but I want to do things in the right way, because my name is my honor. Please do not punish me and inflict these penalties. During that time I had gotten in an accident and was disabled.

My corporation deals with Artistic design and decorations and I am proud to say that I am a very organized individual. I promise you that next year when everything is straightened out I will be one of the first people to file your annual report. The friendly clerk told me over the phone yesterday, to enclose this letter, an application for Reinstatement and a check for \$308.75 that my corporation would revert to its normal opened status. Please also send me if its not too much trouble, a copy of my Articles of Incorporation, because my bank is asking for a copy.
