Dear Mr. and Mrs. Landis:

I stopped by your house today to meet with you, but no one was home. The post office had requested that the County look into the addresses on your street. It was brought to our attention that the addresses over the years had been assigned as a Bahia Vista Street addresses, which follow a 4000 grid. However, the grid system established for the County shows that Bahia Vista Court should follow the 1000 grid established for your street. As a result, some of the new houses on the street have received numbers which correctly reflect the 1000 range and some reflect the incorrect 4000 grid numbers. Allowing the addresses to remain as they are could cause 9-1-1 to not be able to find your house in the event of an emergency.

While I understand that it is uncomfortable to make changes, I must change your address for safety reasons. Therefore, your new address will be **1083 Bahia Vista Court**. The Postal Service will receive this information, and you will be granted one year to make this change. During that year, you will continue to receive mail at your old address as well as the new one. Please keep in mind that you will have to indicate your new address numbers by applying them to BOTH sides of your mailbox and displayed prominently on the front of your home with 4 inch high numbers.

Please indicate your change of address on your bills when you send in your next payment. The change of address will not affect your legal papers for your home, since the address change will be noted during a title search, should you decide to sell your home. Your legal description will remain the same.

Once again, I am sorry that you are having to make this change. Thank you for your cooperation in this matter. Should you have any questions, please do not hesitate to phone this office at (941) 378-6121.
