On thursday 18th., when at work I opened your form 2001 Uniform Business Report due by September 12th., immediately I began to investigate the ware about of check No.2286 mailed on March 14th., once I confirmed by analyzing all the bank statements that the check was not paid, I decided to call your office to find out what should I do, to avoid penalties and any other problem.

Enclosed our new check No.2337 in the amount of \$150.00 and the signed 2001 Uniform Business Report.

Hoping you will understand that the lost of the envelope of March 14th created a problem impossible to control plus the unfortunate health problems which had turned my world upside down.
