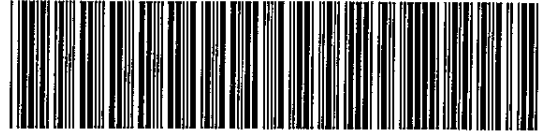

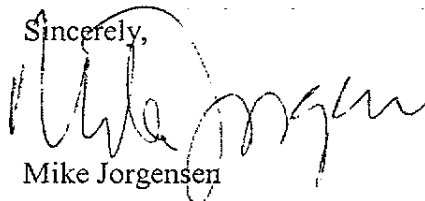

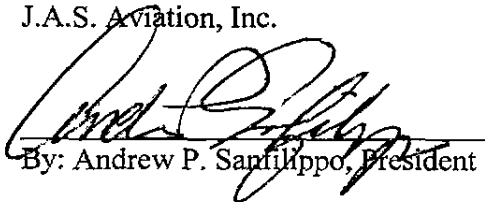

8. The corporation is dissolved upon the effective date of its articles of dissolution.

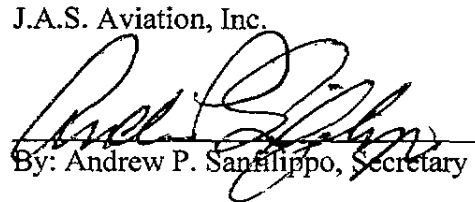

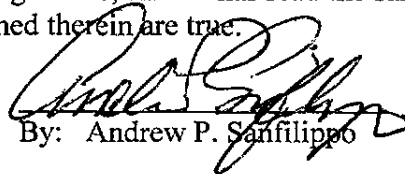
