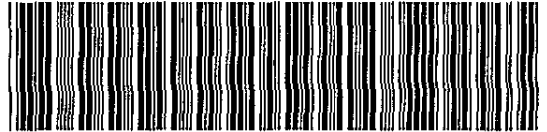

ARTICLES OF AMENDMENT

OF

ARTICLES OF INCORPORATION

OF

TAMPA BAY VETERINARY EMERGENCY SERVICES, INC.

TAMPA BAY VETERINARY EMERGENCY SERVICES, INC., a Florida corporation, under its corporate seal in hand of its President and Secretary, Kathleen M. Meyer, hereby certifies that:

1. The Board of Directors of said corporation, at a meeting called and held on the 15th day of February, 2005, adopted the following resolution:

BE IT RESOLVED by the Board of Directors of Tampa Bay Veterinary Emergency Services, Inc., a Florida corporation, that Article I of the Articles of Incorporation be amended, changed and altered so that it reads as follows:

ARTICLE I - NAME

The name of the corporation shall be:

TAMPA BAY VETERINARY EMERGENCY SERVICES, P.A.

BE IT FURTHER RESOLVED by the Board of Directors of Tampa Bay Veterinary Emergency Services, Inc., a Florida corporation, that Article II of the Articles of Incorporation be amended, changed and altered so that it reads as follows:

ARTICLE II - PRINCIPAL OFFICE AND NATURE OF BUSINESS

The principal place of business and mailing address of the corporation shall be 1501A South Belcher Road, Largo, Florida 33771.

This corporation may engage in every aspect of the business of rendering the same professional services to the public that a veterinarian, duly licensed under the laws of the State of Florida, is authorized to render. This corporation may engage in or transact any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory, or nation.

2. The meeting of the shareholders of the corporation called by the Board of Directors as aforesaid, was held on the 15th day of February, 2005, at said special meeting of the shareholders, said amendment to the Articles of Incorporation was duly adopted by the unanimous vote of all shareholders.
