

Please consider the following circumstances:

On January 6, 1997 we mailed in our Annual Report Fee with the intentions of this payment arriving in your office before the due date. Towards the end of April 1997, our CPA called us to inform and bring to our attention, that the Corporation Annual Report Fee was due, as he does in all occasions where these types of taxes are due. I assured him it has been paid. I also checked with our bookkeeper to make certain this payment had been mailed. We researched the checking account stubs and it was clearly noted that payment was written out. The bookkeeper also informed me that she clearly remembers paying this bill because she stated that this bill was not due for several months. On July 15, 1997, upon checking the mail, we received our second notice stating that we have not paid the original payment. We contacted our bank to find out when the check cleared and they were unable to confirm this. The check must have been lost in the mail or could possibly be internally misplaced in your office.
