The name of the corporation is Evans Fire Protection & Plumbing, Inc. (the "Corporation") and its document number is P94000003501.

2.

The Articles of Incorporation of the Corporation as heretofore granted by the Secretary of State of the State of Florida on January 6, 1994, as heretofore previously amended, are hereby further amended in that the name of the Corporation is changed from Evans Fire Protection & Plumbing, Inc. to Evans Fire Protection, Inc., and to effect this change, the heading and Article I of the Articles of Incorporation of the Corporation are hereby amended, insofar as they refer to the name of the Corporation to read Evans Fire Protection, Inc. in lieu of Evans Fire Protection & Plumbing, Inc.

The proposed amendment of the Articles of Incorporation as set forth in Paragraph hereinabove was approved on Dec. 1, 2005, by joint unanimous written consent of all the members of the Board of Directors of the Corporation and all of the shareholders of the Corporation owning all of the voting stock of the Corporation. The number of votes cast by such voting group was sufficient for approval by that voting group.
