I do a substantial amount of corporate work and in particular, represent Richard S. Hall, the founder, director and president of each of the above referenced corporations. Recently, Mr. Hall brought in the Certificates of Administrative Dissolution or Revocation received from your section. This action came as a complete surprise to Mr. Hall, since he represents to me that none of the annual report forms for the above corporations were received at the principal office. He recently was out of town for several weeks and was not aware of the dissolution action until he returned and opened his mail.

Mr. Hall is at a loss to know why he did not receive the annual reports; however, he found it significant that all of the reports were apparently misplaced. The addresses shown on the applications for reinstatement are correct, so the forms should have been delivered to this address which is the principal place of business of the corporation.

Although I have no personal knowledge as to these matters, I have found Mr. Hall in his dealings with me to be a good, and well organized business person, and it is my opinion that he would have

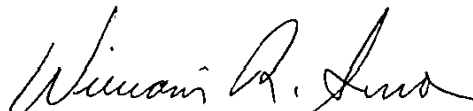
certainly taken care of filing the reports in a timely manner had they been received by him.

In any event, I spoke to "Michelle" on Friday, November 17, 2000, and she advised me to forward a letter of explanation along with the reinstatement forms and the amounts that would have been due had the Uniform reports been filed in a timely fashion, and this matter would be reviewed by your staff. Accordingly, the reports prepared by Mr. Hall are enclosed, along with three checks for \$150.00 each and a fourth check for \$61.25.

I would sincerely appreciate you reviewing this matter, and if at all possible, I respectfully request that you provide a waiver of the large fees that would be required to reinstate these corporations and that these corporations be allowed to be reinstated to a good standing status. Of course, I have advised my client that should this happen once again, your office will be opposed to considering such a request. In addition, my client has put procedures in effect to make sure that the report forms are located within the time permitted for filing, and if not, to take steps at that time to avoid these problems.

If you require any further information, please advise. Otherwise, I sincerely thank you for your consideration of this request.
