We are in the process of reinstating the above mentioned corporation and would like to have your assistance.

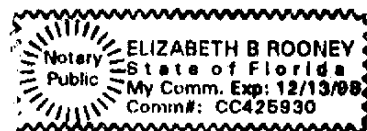
This corporation was incorporated in 1994. All renewal documents were never received from the Secretary of State, so the corporation has not been registered with the State.
