
I enclose the completed form for reinstatement of the above corporation. Your records report it was dissolved on September 21, 2001.

I am requesting that the reinstatement fee be waived as the annual report/ uniform business report form from your office was not received. Your web site reports that the corporation's current address is 608 W. Hozatio St. (Copy of current information enclosed.) While some mail gets to us when the street is not correctly spelled this annual report did not make it to us. The correct spelling of our street name is "Horatio". "Hozatio" first appeared in 1999 and was never corrected. It appears for the addresses for all names and addresses associated with the corporation according to information from the your web site.

In 2000, the corporation's annual report changed the mailing address to be 815 Bayshore Blvd., Tampa, FL 33606. I enclose a copy of the annual report for 2000 your reference.
