**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
ANCICARE PPO, INC.**

Pursuant to the provisions of §607.1006 of the Florida Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The current name of the corporation is ANCICARE PPO, INC. (formerly known as Managed Care Networks, Inc.)(the "Corporation"), document number P94000005521 filed on September 20, 1999.
2. The Amendment to the Articles of Incorporation set forth below was adopted by written consent of the Board of Directors and the shareholders of the Corporation effective as of May 15, 2002, in the manner prescribed by §607.1003 of the Florida Business Corporation Act.
3. Article I of the Corporation's Articles of Incorporation shall be amended in its entirety to read as follows:

ARTICLE I

"The name of the corporation is Managed Care Networks, Inc. (the "Corporation")."

4. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain the same.
5. These Articles of Amendment to Articles of Incorporation of the Corporation shall be effective upon filing with the Secretary of state of the State of Florida.
