FINAL JUDGMENT OF DISSOLUTION

THIS CAUSE is before the Court on Petitioner's Motion for Final Judgment of Dissolution, previously filed in this case. This Court has reviewed the instant motion, exhibits attached thereto, and the court file and finds that:

1. Proper service has been effected on PrimeCare of North Florida, P.A., a professional corporation (PrimeCare) by constructive service on Ralph H. Hartke, Jr., its registered agent and sole director. § 48.081(3), Fla. Stat. (2001); § 49.10, Fla. Stat. (2001).

2. Neither PrimeCare of North Florida, P.A., a professional corporation, nor Ralph H. Hartke, Jr., its registered agent and sole director, have served or filed any paper in this case as required by law. Therefore, the allegations in the complaint are deemed admitted.

3. Ralph H. Hartke, Jr., registered agent and sole director of PrimeCare of North Florida, P.A., a professional corporation, has been suspended indefinitely from the practice of medicine.

4. The Florida Board of Medicine has appointed Alachua County Medical Society permanent custodian of the patient medical records formerly in Hartke's possession. Therefore, it is

ORDERED AND ADJUDGED that PrimeCare of North Florida, P.A., a professional corporation, is hereby DISSOLVED, *nunc pro tunc* to the date

of the Florida Board of Medicine's Emergency Suspension Order of Ralph H. Hartke, Jr. from the practice of medicine, December 1, 2000. All other pending motions are denied as moot.

The Clerk is directed to deliver a certified copy of the Judgment of Dissolution to the Florida Department of State, Division of Corporations, for filing.
