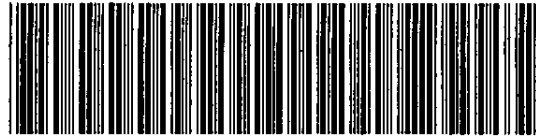

INCORPORATION OF

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, this **Florida Profit Corporation** adopts the following amendment to the Articles of Incorporation of FRANK J. CASTAGNA, D.P.M., P.A., which were filed on January 18, 1994 and assigned Document Number P94000006586.

FIRST: The name of the corporation, prior to the effective date of this amendment, is FRANK J. CASTAGNA, D.P.M., P.A.

SECOND: The following amendment to the Articles of Incorporation changing the name of said corporation was properly adopted pursuant to Florida Statutes, by the sole director of the corporation without shareholder action and shareholder action was not required. Article I of the Articles of Incorporation providing for the name of the corporation is hereby amended to read as follows:

ARTICLE I - NAME

The name of this corporation is changed to PENSACOLA PODIATRY, P.A.

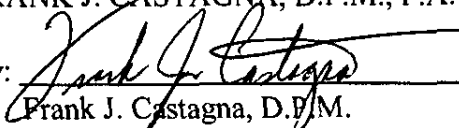
