Dear Sir or Madam:

We are the Certified Public Accountants for the above referenced taxpayer and are writing to you on their behalf. Enclosed is a check made payable to the Department of State for \$150 for the corporation's 2002 Uniform Business Report (UBR). Although this report is being filed after the May 1, 2002 deadline, we are requesting that the late filing penalty of \$400 be abated due to reasonable cause.

The corporation failed to timely file the 2002 UBR as the corporation had ceased operations on January 1, 2002. Our office advised the corporation that if they did not file the UBR, the corporation would be administratively dissolved or its status revoked and it would no longer be recognized as an active corporation. Since this was consistent with the corporation's intent to cease operations permanently, the 2002 UBR was not filed.

However, the corporation's legal counsel has recently advised the corporation's officers that under Florida Statutes 607.1622 (8) "any corporation failing to file an annual report which complies with the requirements of this section shall not be permitted to maintain or defend any action in any court of this state until such report is filed and all fees and taxes due under this act are paid and shall be subject to dissolution or cancellation of authority as provided in this act." As a result of subsequent litigation, their counsel has advised the officer's of the corporation that they must maintain the entity's corporate existence to enable the entity to defend against the litigation.

The corporate officer's request that the late filing penalty be abated based on the above unusual circumstances. The corporation normally files its annual report in January or February of each year and would have timely filed its 2002 UBR if the officer's had been aware of their continuing requirement to maintain their corporate existence.
