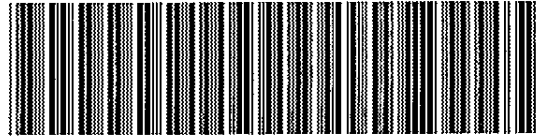

This Plan of Merger, was adopted and approved by each party to the merger in accordance with FS §607.1108 and a certificate or articles of merger will be filed with the Florida Department of State in accordance with FS §607.1109.

Since all stock in both corporations is owned by the same shareholder and that shareholder will own all the stock in the surviving corporation subsequent to the merger, there is no consideration being paid for this transaction.


The shares of E & P Real Estate, Inc. will be redeemed and replaced by the existing authorized and outstanding shares in Suwannee Valley Cancer Center, Inc. The Articles of Incorporation and Bylaws of Suwannee Valley Cancer Center, Inc. shall survive and remain the Articles and Bylaws of the merged corporations.

It is planned that this merger will be completed no later than November 30, 2002.


FOURTH: All shares of E & P Real Estate, Inc. will be canceled upon completion of the merger.
