It has just come to our attention that an order for dissolution was issued for the above named companies on Sept 24, 1999. Apparently this arises from failure to file the Annual Report of the Corporations for 1999.


We enclose copies of the Annual Reports along with copies of checks issued Mar 12 1999 for each.

We surmise that it may have been a confusion of names involving the above that has caused this situation. As well, it was around that time that the Corporation changed its bankers and perhaps the error occurred in the changeover.

We have confirmed that the Mar 12, 1999 checks, drawn on the old bank, First Union, were not cleared, and we enclose new checks, drawn on our new bank, NationsBank.

We respectfully request a waiver of the dissolution and acceptance of the enclosed as proper filing.
