The mail man who was supposed to drop this 1st Notice in our mail box, probably by mistake, dropped it in the mail box of the booth next door to ours.


Unluckily, This booth was not rented for several months. Now that a new company has taken place in that lot, this document with 2 other letters was only handed to us on June 12th.
