


To Whom It May Concern:


Please consider abatement of the late filing penalty of \$400 based on the following cause:  
During the calendar year 2003, I moved from 5764 Wingate Drive, Orlando, Florida 32839 to 20031 Quinella Street, Orlando, Florida 32833. Because of this move, I believe that the form may have been sent back to the Division of Corporations because I never received the form in the mail.

On or about May 15<sup>th</sup>, 2004, I met with my accountant and he inquired whether I had filed the 2004 Uniform Business Report and informed me that the procedure had changed by the Division of Corporations. The State was now mailing out post cards and you could access the preprinted forms on the internet.
