AMENDMENT TO THE ARTICLES OF INCORPORATION OF FLIGHT AVIONICS OF NORTH AMERICA, INC. DIVISION OF FILED OIDEC 10 AM 8: 30

A special meeting of the Board of Directors and Shareholders of the corporation organized and existing under and by virtue of the laws of the State of Florida, was held at Orlando, Florida on the 4 day of Necember, 2001, pursuant to proper call and notice of the meeting. The Directors and Shareholders unanimously resolved that the Articles of Incorporation be amended as follows:

1. Article Four shall be amended to read:

"The aggregate number of common shares which the corporation shall have authority to issue is Two Hundred Forty Three Thousand Seven Hundred Fifty (243,750) common shares without par value. The corporation shall also be authorized to issue 43,750 shares of Class A convertible preferred stock with a cumulative annual dividend of eight percent (8%) without par value. These dividends shall be paid quarterly. The shares may be converted on a one-to-one basis to common stock and shall carry the same voting rights as the common stock. The deadline for conversion shall be January 1, 2007. If not converted by that date, the corporation will redeem the shares no later than December 31, 2007, at original value plus accrued interest."

2. Article Six shall be added to read:

"SIX: Amendments to the Articles of Incorporation and By Laws shall require an affirmative vote of seventy percent (70%) of the outstanding shares entitled to
