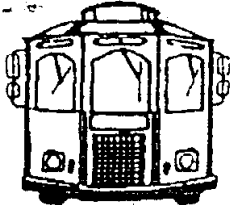

I am writing to please advise you I did not receive the 1st Original 2002 Uniform Business Report, and I am sorry I completely overlooked the filing date of May 1, 2002 for Incorporation Filing as in previous years, and just in this last week received the 2nd Late Notice as the business address changed with mail forwarded.

Trolley Systems of America, Inc. (TSA, Inc.) and I (Brenda A. Cremeans) have had an extremely hardship past year. My husband (Gary E. Cremeans) passed away April 2, 2001.
