Pursuant to the provisions of section 607.1006, Florida Statutes, this corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: Amendments adopted:

Article I – The name of this corporation should be changed from Christian Financial Ministries, Inc. to JOHN A. KASPAR, P.A.

Article XVI – location of registered office should be changed to 2320 NE 2nd Street, Suite 1a, Ocala, FL 34470.

SECOND: The shares issued in the name of Christian Financial Ministries, Inc. have been recalled and shares of JOHN A. KASPAR, P.A. have been issued in their place.

THIRD: The date of each amendments adoption should be effective beginning January 1, 1997.
