#### AMENDED AND RESTATED

#### ARTICLES OF INCORPORATION OF

#### FOUNDING PARTNERS CAPITAL MANAGEMENT COMPANY

Pursuant to the provisions of Section 607.1007 of the Florida Business Corporation Act, the undersigned, being the sole director of FOUNDING PARTNERS CAPITAL MANAGEMENT COMPANY, a Florida corporation (the "Corporation"), whose Articles of Incorporation were originally filed with the Florida Department of State on February 9, 1994, and amended on May 11, 1994, and assigned charter number P94000011946, hereby adopt the following Amended and Restated Articles of Incorporation:

- 1. The name of the corporation is FOUNDING PARTNERS CAPITAL MANAGEMENT COMPANY.
- 2. The street address of the principal office, which is also the mailing address, of the Corporation is:

- 3. The aggregate number of shares that the Corporation is authorized to issue is as follows:
  - Ten Thousand (10,000) shares of common stock, and the par value of such à. shares shall be One Cent (\$0.01). Par value shall have no effect on the Corporation's capital structure;
  - Ъ. Of the Ten Thousand shares of common stock authorized, One Thousand (1,000) shares shall be voting common stock (the "Voting Common Stock"); and
  - C. Of the Ten Thousand shares of common stock authorized, the remaining Nine Thousand (9,000) shares shall be non-voting common stock (the "Non-Voting Common Stock"). The Non-Voting Common Stock shall have and enjoy the same rights, preferences and privileges as the Voting Common Stock, and shall, for all purposes, be and act as a single class of shares, except that the shares of the Non-Voting Common Stock shall not be entitled to vote on any matter, unless otherwise required by law. Each holder of the shares of Voting Common Stock shall be entitled to one vote for each share of Voting Common Stock held by such holder. Each holder of shares of Non-Voting Common Stock shall not be entitled to vote on any matter by virtue of the holder holding such shares of Non-Voting Common Stock, unless otherwise required by law.
