Enclosed please find our 1998 Corporation Annual Report. This report was originally filed on April 2, 1998 along with our check 012442 which we just learned today was never received by your office.


We are also enclosing a replacement check for the \$150 since we timely filed our annual report and we have always filed our report on time.
