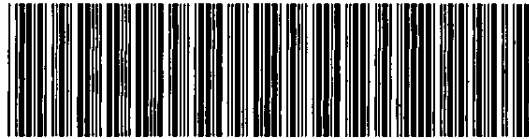

The name of the corporation is Fuller Holsonback & Malloy, P.A.


THIRD: The foregoing amendment to Article I was adopted and approved by the board of directors and shareholders of the corporation by written consent without a meeting on March 27, 2007.


