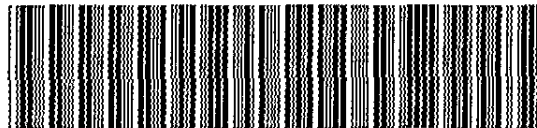

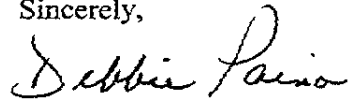

ARTICLES OF INCORPORATION OF
