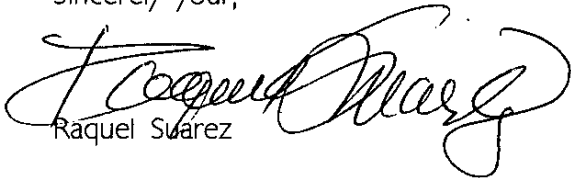
This will confirm the matter discussed with one of your attendants today regarding filing of our annual reporting.
