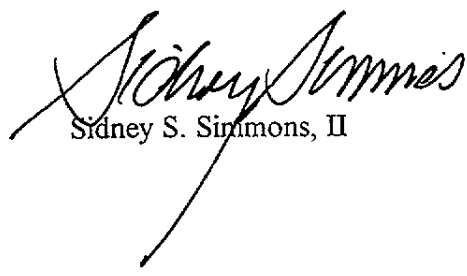

**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION

Pursuant to Section 607.1006, Florida Statutes, SECOND HAND ROSE NURSERY AND LANDSCAPING, INC. hereby delivers to the Department of State for filing these articles of amendment:

1. The name of the corporation is Second Hand Rose Nursery and Landscaping, Inc.
