The name of the corporation shall be: **Dorn Properties, Inc.**

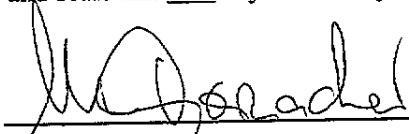
Article I of the Articles of Incorporation are hereby amended to read as follows:
