ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF

PROFESSIONAL TRAINING CENTERS INC.

Pursuant to the provisions of §617.1006 of the Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is PROFESSIONAL TRAINING CENTERS INC.
2. The following amendments of the Articles of Incorporation were adopted by the shareholders of the corporation on December 9, 2002 in the manner prescribed by the Florida Business Corporation Act:

RESOLVED, that Article IV of the Articles of Incorporation of PROFESSIONAL TRAINING CENTERS, INC. be amended to read as follows:

"The total number of shares of stock that may be issued by this corporation is 2,000 shares of common stock at \$1.00 par value. All of said stock may be issued for consideration consisting of any tangible or intangible property or benefit to the corporation, including cash, promissory notes, services performed, promises to perform services evidenced by a written contract, or other securities of the corporation so long as the Board of Directors has determined that the consideration received or to be received for the shares to be issued is adequate."

3. The number of shares of the corporation outstanding at the time of the adoption was 100 and the number of shares entitled to vote on the amendments was 100.
4. The number of shares voted for the amendment was 66 2/3 and the number of shares voted against the amendment was 0. The amendment was approved by the shareholders. The number of votes cast for the amendment was sufficient for approval.
