WHEREAS, the Articles of Incorporation of Automotive Information Systems, Inc. (the "Corporation") were filed with the Florida Department of State on March 3, 1994;

WHEREAS, it is the intention of the sole Director and sole Shareholder of the Corporation that the Articles of Incorporation of the Corporation be amended, effective the date this Amendment is filed with the Florida Department of State, in accordance with the proposed amendment hereinafter set forth; and

WHEREAS, the proposed amendment to the Articles of Incorporation of the Corporation as hereinafter set forth was approved by written action of the sole Director and sole Shareholder, pursuant to the provisions of Section 607.1003, 607.0704, and 607.0821 of the Florida Business Corporation Act on the 10th day of November, 1999.

NOW, THEREFORE, the Articles of Incorporation of the Corporation are hereby amended effective the date this Amendment is filed with the Florida Department of State, as follows:

1. Article I is deleted in its entirety and the following is substituted therefor:

The name of this Corporation shall be "GTTF Publishing, Inc."


