Further to my conversation with your office today, May 29, 2007, we ask that you accept this explanation for your not receiving both of the above Annual Reports for 2007 in a timely manner.

We did send, on 3/30/07, both annual reports by mail, together with fees of \$150.00 for each company on one check (as copy attached).

In that the Officers of Bylands Management was due to change at the end of April, your office advised us to delete the current officers and mail a new form together with a fee of \$61.25 (copy enclosed).
