1. The name of the corporation is Tech Data France, Inc. (the "Corporation").
2. Article VI of the Articles of Incorporation of the Corporation is amended to read as follows:

ARTICLE VI
CAPITAL STOCK

The corporation is authorized to issue One Million (1,000,000) shares of One Dollar (\$1.00) par value common stock.

3. This Amendment was recommended by the board of directors to the Corporation's shareholders on August 28, 1998.
4. This Amendment was approved by all of the holders of the Corporation's common stock, on August 28, 1998, by unanimous vote in favor of the Amendment.
5. The Amendment shall become effective upon filing with the Florida Secretary of State.
