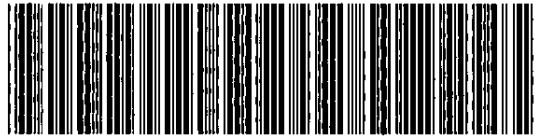

The name of the corporation is Ibis Lake Realty, Inc. ("Corporation").

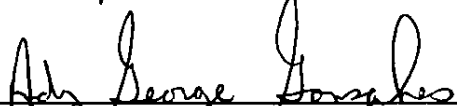
ARTICLE II - DATE AUTHORIZED
