Pursuant to the Florida Business Corporation Act, Section 607.1006, the undersigned corporation does hereby adopt the following amendments to the Articles of Incorporation, which amends the original Articles of Incorporation as follows:

1. The name of the corporation is Gun Gallery, Inc. (Document Number P94000020182).
2. As a result of the sale of substantially all of the assts, including the tradename "Gun Gallery" and the sale of the real property of the corporation, the following articles, and only the following articles, of the Articles of Incorporation of the corporation shall be amended in their entirety to read as follows:

ARTICLE I – NAME

The name of this Corporation is HiTech Innovations Corp.

ARTICLE II – PRINCIPAL OFFICE AND MAILING ADDRESS

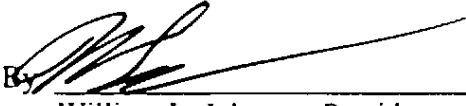
3. This document is being filed merely to reflect a change in the registered office address, and I hereby confirm that the corporation has been notified in writing of this change.

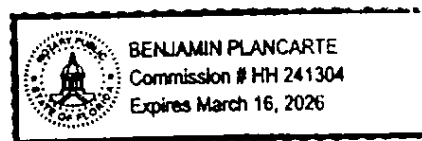
