1. Pursuant to Section 607.1006 of the Florida Statutes, Article 1 of the Articles of Incorporation of RAHDERT, ANDERSON, MCGOWAN & STEELE, P.A. (the "Corporation") is hereby amended to read in its entirety as follows:

**"ARTICLE I - NAME**


The name of the Corporation shall be **RAHDERT, ANDERSON & STEELE, P.A.**

2. As hereby amended, the Articles of Incorporation of the Corporation are hereby ratified and affirmed.

3. The foregoing Articles of Amendment (the "Amendment") was adopted with the consent of the Directors of the Board of Directors and the Sole Shareholder of the Corporation in accordance with Sections 607.0704 and 607.0821, Florida Statutes, on the 15<sup>th</sup> day of September, 2000.

4. The only voting groups entitled to vote separately on the Amendment is the sole shareholder of the Corporation and the directors, and the number of votes cast for the Amendment by such shareholder and directors was sufficient for the approval of the Amendment by those voting groups.
