

## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

1. Pursuant to Section 607.1006 of the Florida Statutes, Article I of the Articles of Incorporation, as amended, of RAHDERT, STEELE, BOLE & REYNOLDS, P.A. (the "Corporation") is hereby amended to read in its entirety as follows:
