As we discussed, the corporation "ANDREA K. BLUMBERG, MD, PA" was administratively dissolved on 9/26/97 due to non-filing of the 1997 annual report. When you looked into the account, you indicated that the 1997 report had been returned to Tallahassee by the post office. Therefore, my client, Andrea Blumberg, never received the annual report and henceforth, never paid or filed the annual report. As you can see, she did file and pay in 1995 and 1996 both years she received the annual report. It appears from looking at the account, that there was a typographical error on her mailing address as being SouthWEST 2nd Court instead of the correct address of SouthEAST 2nd Court. I don't know if this was the cause for her report to be returned, however, the correct address which is listed with the registered agent is SouthEAST. Please correct this on your records and abate any and all penalties for late filing.

I have completed an annual report (and \$150) with a blank form and submit it herewith along with a check for \$315 consisting of \$165 for 1997 and \$150 for 1998.
